




# OUR CO-INVESTMENT OPPORTUNITIES

How to proceed with the investment?

- The company shall provide a bond paper agreement mentioning the terms decided and signed by all the directors of the company along with registration of the investor in registrar of companies as an investor.
- The interest calculation shall start from the date bond paper agreement is signed and investor is taken on board.
